Under the One Big Beautiful Bill Act, solar and wind projects must begin construction by July 2026 or be placed in service, meaning reaching commercial operation, by Dec. The Trump administration's move to tighten “start of construction” rules for renewable energy projects in the US will make it more difficult for projects to obtain the Investment Tax Credit (ITC) and Production Tax Credit (PTC), support many developers have been counting on to realise their. Final guidance eliminates the 5% safe harbor for projects over 1.5 MW, forcing developers to prove “physical work of a significant nature” to qualify for federal solar tax credits.
