

# Portugal electric vehicle incentives

Portugal will reopen applications for its national incentive for electric vehicles on 29 December 2025, releasing €17.6 million to encourage low emission transport across the country. Managed by the Fundo Ambiental, the program will remain available until 12 February 2026 or until. The government has quietly pressed the reset button on its flagship electric-mobility incentives, and anyone in Portugal who has bought – or is thinking of buying – a low-emission vehicle since 1 January 2025 now has a shot at claiming fresh cash support.
